2021 CURRENT USE REPORT

This report presents the 2021 Current Use Report as compiled by the New Hampshire Department of Revenue Administration.

Annually, each municipality is required to report and certify to the Department of Revenue Administration the assessed valuation of all taxable property in the municipality, including current use, on the MS-1, Summary Inventory of Valuation Report.

Information in this report includes, for each municipality:

- Total land acres, total acres enrolled in current use, the number of owners and parcels
- Total current use acres and percentage receiving the 20% recreation adjustment
- Total acres removed from current use in 2021 and estimated land use change tax (LUCT)
- Total acres removed from current use in 2020, the actual LUCT received, amount of LUCT placed in a conservation fund and the general fund and percent into conservation fund
- Number of acres within each current use category including farm land, forest land, forest land with documented stewardship, unproductive land and wet land
- Total non-taxable conservation acres and a breakdown of current use and conservation land and their percentage of the total land acres

Report Notes:

- (1) Total land acres within each municipality per the NH Office of Strategic Initiatives. (This number does not include water acres.)
- (2) Total current use acres as reported by each municipality on the MS-1, Summary of Valuation Report (MS-1).
- (3) Number of owners having land enrolled in current use as reported on the MS-1.
- (4) Estimated land use change tax as reported by each municipality on form MS-434, Estimated Revenues.
- (5) Actual LUCT received in the prior calendar year as reported on the MS-1.
- (6) Land use change tax allocation to conservation funds pursuant to RSA 79-A:25-a, as reported on the MS-1.
- (7) Conservation acres, including:
 - a. Federal and state acres provided by the NH Office of Strategic Initiatives
 - b. White Mountain National Forest acres as provided by the US Department of Agriculture and White Mountain National Forest (Campton – office).
- (8) Percent of conservation acres of total land acres (total land acres minus conservation acres).
- (9) Percent of conservation and current use acres combined of total land acres

(total land acres minus conservation land acres).

Note: The percentage of conservation acres and conservation and current use acres does include all non-taxable or tax exempt acres as those figures are not provided.

Definitions:

- Current use value means the assessed valuation per acre of open space land based upon the income-producing capability of the land in its current use and not its real estate market value. This valuation shall be determined by the assessor in accordance with the range of current use values established by the board and in accordance with the class, type, grade and location of the land.
- Farm Land means any cleared land devoted to or capable of agricultural or horticultural use as determined and classified by criteria developed by the NH Commissioner of Agriculture, Markets, and Food and adopted by the Current Use Board.
- Forest Land means any land growing trees as determined and classified by criteria developed by the state forester and adopted by the board. For the purposes of this paragraph, the board shall recognize the cost of responsible land stewardship in the determination of assessment ranges.
- Land Use Change Tax means a tax that shall be levied when the land use changes from open space to a nonqualifying use.
- Unproductive Land means land, including wetlands, which by its nature is incapable of producing agricultural or forest products due to poor soil or site characteristics, or the location of which renders it inaccessible or impractical to harvest agricultural or forest products, as determined and classified by criteria developed by the board. The board shall develop only one category for all unproductive land, setting its current use value equal to that of the lowest current use value established by the board for any other category.
- Wet Land means those areas of farm, forest and unproductive land that are inundated or saturated by surface water or groundwater at a frequency and duration sufficient to support and that under normal circumstances do support, a prevalence of vegetation typically adapted for life in saturated soil conditions.
