#### Readopt with amendment Cub 305.03, effective 8-23-19 (Doc. #12857-B), to read as follows:

Cub 305.03 <u>Assessment Ranges for Forest Land Categories</u>. The assessment ranges for forest land categories without documented stewardship shall be as follows:

(a) The category of white pine shall be [\$118 to \$176] \$122 to \$183 per acre;

- (b) The category of hardwood shall be [\$57 to \$86] \$61 to \$91 per acre; and
- (c) The category of all other shall be [<del>\$38 to \$57</del>] <u>**\$39 to \$59**</u> per acre.

#### Readopt with amendment Cub 305.04, effective 8-23-19 (Doc. #12857-B), to read as follows:

Cub 305.04 <u>Assessment Ranges for Forest Land Categories with Documented Stewardship</u>. The assessment ranges for forest land categories with documented stewardship shall be as follows:

- (a) The category of white pine shall be [\$71 to \$106] \$73 to \$110 per acre;
- (b) The category of hardwood shall be [<del>\$34 to \$52</del>] <u>**\$36 to \$55**</u> per acre; and
- (c) The category of all other shall be  $[\frac{23 \text{ to } 334}{34}]$  per acre.

#### Readopt with amendment Cub 305.05, effective 8-23-19 (Doc. #12857-B), to read as follows:

Cub 305.05 <u>Assessment Range for Unproductive Land</u>. The assessment for unproductive land shall be [\$23] \$24 per acre.

#### Readopt with amendment Cub 305.06, 8-23-19 (Doc. #12857-B), to read as follows:

Cub 305.06 <u>Assessment Range for Wetland</u>. The assessment for wetland shall be [\$23] \$24 per acre.
