Friday, March 10	Last day for petitioned bond articles over \$100,000	40:13, II-c (b), 33:8-a	"...the second Tuesday in March, provided however, that if a petitioned article proposes a bond governed by RSA 33:8-a, the deadline shall be the preceding Friday."
