#### 2019 VETERANS ' TAX CREDITS SUMMARY REPORT

This report presents the 2019 Veterans' Tax Credits Summary as compiled by the New Hampshire Department of Revenue Administration.

Annually, each municipality is required to certify to the Department of Revenue Administration the assessed valuation of all taxable property in that municipality. This information is reported on the Summary Inventory of Valuation, MS-1 Report.

Assessment information is also gathered regarding exemptions and tax credits as well as taxes raised by each municipality. An exemption is an amount deducted from a taxpayer's assessment vs. a tax credit which is an amount deducted from the taxes due by a taxpayer.

The following is an explanation of the information contained in this report.

**VETERANS' TAX CREDITS:** Amounts granted per municipality:

- VETERANS' TAX CREDIT: <u>RSA 72:28</u> Standard \$50 / Optional \$51 up to \$750
- ALL VETERANS' TAX CREDIT: <u>RSA 72:28-b</u> If adopted by municipality -Standard \$50 / Optional \$51 up to \$750
- SURVIVING SPOUSE: <u>RSA 72:29-a</u> Standard \$700 / Optional \$701 up to \$2,000
- TAX CREDIT FOR SERVICE CONNECTED TOTAL DISABLITY: <u>RSA 72:35</u> -Standard \$700 / Optional \$701 up to \$4,000
- TAX CREDIT FOR COMBAT SERVICE: <u>RSA 72:28-c</u> If adopted by municipality \$50 up to \$500
- CERTAIN DISABLED VETERANS (EXEMPTION) <u>RSA 72:36-a</u>

The information presented in this report includes:

- Name of municipalities
- Whether they have adopted the veterans' tax credit/exemption
- Number of tax credits/exemptions granted
- Amount of tax credits/exemptions
- Total amount of actual monies granted

To apply for any tax credits or exemptions and file with the municipality, complete the form <u>PA-29</u>, Permanent Application for Property Tax Credits/Exemptions. If property is held in a life estate or trust, the form <u>PA-33</u>, Statement of Qualification for Property Tax Credit, Exemption or Tax Deferral under RSA 72:33, V must also accompany the PA-29.
